PROCEDURAL ORDER

BY THE COMMISSION:

On April 10, 2001, the Securities Division ("Division") of the Arizona Corporation Commission ("Commission") filed a Notice of Opportunity for Hearing Regarding the Temporary Order to Cease and Desist, for Restitution, for Administrative Penalties, and for Other Affirmative Action ("Notice") against Accelerated Success, Inc.; Kenneth R. Morris; Robert D. Pierson; Integrity Assured Life Settlements, Inc.; and Steven S. Levine, d/b/a Steven S. Levine Chartered (collectively the "Respondents") in which the Division alleged that Respondents have engaged in acts, practices, and transactions that constitute violations of the Arizona Securities Act ("Act").

Robert D. Pierson, Integrity Assured Life Settlement, Inc. and Steven S. Levine, d/b/a Steven

1 S. Levine Chartered were all duly served with copies of the Notice.

2 On April 20, 2001, Robert D. Pierson, through his attorney, filed a request for a hearing and a
3 pre-hearing conference.

4 On April 26, 2001, the Commission, by Procedural Order, scheduled a pre-hearing conference
5 for May 3, 2001 in this matter.

6 On May 1, 2001, the Commission was contacted by telephone by Robert Howard, an attorney
7 in Washington D.C. Mr. Howard informed the Commission that he represented Integrity Assured
8 Life Settlement, Inc. and Steven S. Levine, d/b/a Steven S. Levine Chartered and that his clients had
9 just informed him of the pre-hearing date set in this matter.

10 On May 2, 2001, Mr. Howard contacted the Commission by telephone and informed the
11 Commission that he would like to attend the pre-hearing conference on May 3, 2001 by telephone.
12 He indicated that he had contacted Staff and Mr. Salcido and that neither party objected.

13 On May 3, 2001, the pre-hearing was held as scheduled. Mr. Pierson, Integrity Assured Life
14 Settlement, Inc. and Steven S. Levine, d/b/a Steven S. Levine Chartered were represented by counsel.
15 The Division also appeared with counsel. Following discussions between the parties, it was agreed
16 that a hearing should be scheduled on the issues raised in the Notice during the week of July 16,
17 2001. Mr. Pierson, Integrity Assured Life Settlement, Inc. and Steven S. Levine, d/b/a Steven S.
18 Levine Chartered agreed to waive all applicable time limits in this matter and have agreed to the
19 abide by the temporary order until this matter is concluded. In the interim, the parties agreed to
20 attempt to resolve the issues raised by the Notice.

21 Accordingly, a hearing should be scheduled to address the issues raised in the Notice and the
22 presentation of evidence.

23 IT IS THEREFORE ORDERED that a hearing on the above-captioned matter shall be held on
24 July 16, 2001, at 10:00 a.m., at the Commission's offices, 1200 West Washington Street, Phoenix,
25 Arizona.

26 IT IS FURTHER ORDERED that the parties shall also set aside July 17, 18, 19 and 20, 2001
27 for additional days of hearing, if necessary.


28 IT IS FURTHER ORDERED that Mr. Pierson, Integrity Assured Life Settlement, Inc. and

1 Steven S. Levine, d/b/a Steven S. Levine Chartered shall comply with the Temporary Cease and
2 Desist Order until the issuance of a Decision by the Commission in this matter.

3 IT IS FURTHER ORDERED that the parties shall exchange witness lists and exhibits not
4 later than 10 days before the hearing and provide a copy of same to the presiding Administrative Law
5 Judge.

6 IT IS FURTHER ORDERED that Robert Howard, attorney for Integrity Assured Life
7 Settlement, Inc. and Steven S. Levine, d/b/a Steven S. Levine Chartered, shall file a pro hac vice
8 motion, a notice of appearance and a motion requesting a hearing that waives the applicable time
9 limits in this matter with the Commission by May 18, 2001.
