**PROCEDURAL ORDER**

Respondents.

**BY THE COMMISSION:**

On August 14, 2001, the Securities Division ("Division") of the Arizona Corporation Commission ("Commission") filed a Notice of Opportunity for Hearing Regarding Proposed Order to Cease and Desist and Other Relief ("Notice") against 21<sup>st</sup> Century Satellite ("21<sup>st</sup> Century"), Howard Baldwin ("Baldwin"), Glenn A. Liberatore Financial Services ("GLFS") and Glenn A. Liberatore ("Liberatore") (collectively the "Respondents") in which the Division alleged that the Respondents had committed multiple violations of the Arizona Securities Act ("Act") in connection with the offer and sale of securities.

The Respondents were duly served with copies of the Notice.  
On September 18, 2001, Respondents Liberatore and GLFS filed a request for a hearing.  
On September 20, 2001, Respondent Baldwin filed a request for a hearing.  
Accordingly, a pre-hearing conference should be scheduled to address the issues raised in the

1 Notice and the presentation of evidence.

2 IT IS THEREFORE ORDERED that a pre-hearing conference shall be held on October 31,  
3 2001, at 9:30 a.m., at the Commission's offices, 1200 West Washington Street, Phoenix, Arizona.
