PROCEDURAL ORDER

BY THE COMMISSION:

On June 28, 2002, the Securities Division ("Division") of the Arizona Corporation Commission ("Commission") filed a Notice of Opportunity for Hearing Regarding Proposed Order to Cease and Desist ("Notice") against Charles E. Conatser and Estate Conservation Strategies, Inc. ("ECSI"), (collectively the "Respondents") in which the Division alleged multiple violations of the Arizona Securities Act ("Act") in connection with the offer and sale of securities in the form of notes.

Respondents were duly served with copies of the Notice.

On July 8, 2002, Respondents filed a request for hearing.

On July 10, 2002, by Procedural Order, a pre-hearing conference was scheduled.

On July 30, 2002, at the pre-hearing conference, the Respondents and the Division appeared through counsel. Although the parties are negotiating a form of Consent Order, in the event that it is not concluded and approved by the Commission, the parties agreed that a hearing should be scheduled in approximately 60 days.

Accordingly, a hearing should be held on the allegations contained in the Notice, if a Consent Order is not concluded and approved by the Commission.
