




DECLARATION OF MICHAEL SALCIDO

MICHAEL SALCIDO states, under penalty of perjury, as follows:

1. I have spoken with Robert H. Roberts, who authorized me to represent him and his entities, Bob's Cash Express, Inc., Bob's Land One, Inc., Challenge/Land USA, Inc., Arizona Digital Security Tech., Inc., and American Dish Tech, Inc.
2. I have also spoken with Respondents Garrett Wright, Joyce Goodman, and Dan Harper, who have authorized me to appear on their behalf, and file a request for hearing.
