**PROCEDURAL ORDER**

9 **BY THE COMMISSION:**

10 On May 31, 2002, the Securities Division ("Division") of the Arizona Corporation  
11 Commission ("Commission") filed a Notice of Opportunity for Hearing ("Notice") against David R.  
12 Krizman ("Respondent"), in which the Division alleged multiple violations of the Arizona Securities  
13 Act ("Act") in connection with the offer and sale of securities in the form of viatical settlements  
14 and/or investment contracts.

15 The Respondent was duly served with a copy of the Notice.

16 On June 18, 2002, Walter L. Baumgardner, a Michigan attorney, filed a request for hearing  
17 for Respondent.

18 Accordingly, a pre-hearing conference should be held on the allegations contained in the  
19 Notice.

20 IT IS THEREFORE ORDERED that a pre-hearing conference shall be held on July 11, 2002  
21 at 10:00 a.m., at the Commission's offices, 1200 West Washington Street, Phoenix, Arizona.

22 IT IS FURTHER ORDERED that Walter L. Baumgardner shall file an application *pro hac vice* in the  
23 above-captioned matter and associate with Arizona counsel pursuant to Rule 33(d) of the Arizona  
24 Supreme Court.
