PROCEDURAL ORDER

BY THE COMMISSION:

On August 23, 2002, the Securities Division ("Division") of the Arizona Corporation Commission ("Commission") filed a Temporary Order to Cease and Desist ("T.O.") and a Notice of Opportunity for Hearing ("Notice") against Turn Two Trading Club ("TTTC"), Dennis Wayne Little and Deborah L. Sorenson Little (collectively "Respondents"), in which the Division alleged multiple violations of the Arizona Securities Act ("Act") and the Investment Management Act ("IMA") in connection with the offer and sale of securities in the form of investment contracts. As a result of the T.O., the Respondents were immediately ordered to cease and desist from violating the Act and the IMA.

The Respondents were duly served with copies of the T.O. and Notice.

On September 10, 2002, a request for hearing was filed on behalf of the Respondents, but without an Answer pursuant to A.A.C. R14-4-305.


Accordingly, a pre-hearing conference should be scheduled to address the issues raised in the T.O. and Notice and the presentation of evidence.

IT IS THEREFORE ORDERED that a pre-hearing conference shall be held on October 8,
