PROCEDURAL ORDER

BY THE COMMISSION:

On March 17, 2003, the Securities Division ("Division") of the Arizona Corporation Commission ("Commission") filed a Notice of Opportunity for Hearing Regarding Proposed Order to Cease and Desist, for Restitution, for Administrative Penalties, and for Other Affirmative Action ("Notice") against Wesley Karban Wyatt and Jane Doe Wyatt in which the Division alleged that they engaged in acts, practices and transactions that constitute violation of the Arizona Securities Act ("Act").

On March 18, 2003, Mr. Wyatt ("Respondent"), through his attorney, filed a Notice of Appearance, Request for Hearing, Motion to Quash Subpoena Duces Tecum and Wes Wyatt's Notice of Privilege.

Accordingly, a pre-hearing conference should be scheduled to address the issues raised in the Notice, the filings made by Respondent, the presentation of evidence, the scheduling of discovery timelines and to set a hearing date.

IT IS THEREFORE ORDERED that a pre-hearing conference shall be held on April 21, 2003 at 9:00 a.m. at the Commission's offices, 1200 West Washington, Phoenix, Arizona.

IT IS FURTHER ORDERED that the Division shall respond to Respondent's Motion to Quash Subpoena Duces Tecum and Notice of Privilege on or before April 8, 2003.


