**SECOND PROCEDURAL ORDER**

**BY THE COMMISSION:**

On December 14, 2001, the Securities Division ("Division") of the Arizona Corporation Commission ("Commission") filed a Notice of Opportunity for Hearing Regarding Proposed Order of Revocation and For Other Affirmative Action ("Notice") against James T. M. Verbic ("Verbic" or "Respondent") in which the Division alleged that Respondent engaged in acts, practices and transactions that constitute violation of the Arizona Securities Act ("Act").

Respondent was duly served with copies of the Notice.

On December 31, 2001, Respondent, through his attorney, filed a request for hearing.

On January 7, 2002, the Commission issued a Procedural Order that set this matter for a pre-hearing on January 16, 2002.

On January 10, 2002, the Division filed a Stipulated Motion to Continue. In the Motion, the attorney for the Division indicates she will be unavailable on the date set for the pre-hearing. The Division requested that this matter be continued to a later date. In its motion, the Division indicates that the Respondent does not object to the continuance and waives the applicable time limits in this matter.

The Commission finds that a continuance is in the interests of justice; that it is not intended to delay the proceedings; that all parties have agreed to the continuance; and that all applicable time limits are waived in this matter. Accordingly, the hearing should be rescheduled.

1 IT IS THEREFORE ORDERED that the hearing on the above-captioned matter set for  
2 February 14, 2002 shall be vacated and the hearing is continued until March 5, 2002, at 1:00p.m., at  
3 the Commission's offices, 1200 West Washington Street, Phoenix, Arizona.


