Pursuant to the United States Bankruptcy Code (11 U.S.C. §101, et seq.), undersigned bankruptcy counsel for the Debtor, in the capacity of bankruptcy counsel only, for the limited purposes of giving this notice without entering any general appearance herein, hereby gives notice of the pendency of the Debtor's bankruptcy proceeding. Please take notice that Easy Money Auto Leasing, Inc. (the "Debtor") filed its Chapter 11 voluntary Petition (the "Petition") with the United States Bankruptcy Court for the District of Arizona as case number 00-09192-ECF-CGC on August 23, 2000. (The "Bankruptcy Case"). Please take notice that, pursuant to 11 U.S.C. §362 and the United States Bankruptcy Code, the filing of the Petition with the U.S. Bankruptcy Court operates as an immediate and automatic stay of the commencement or

continuation of any judicial, administrative, or other action or proceeding against the Debtor or its property that was or could have been commenced before the filing of the Petition, or to recover any claim against the Debtor that arose before the commencement of the Bankruptcy Case.

Counsel undersigned as bankruptcy counsel to Easy Money Auto Leasing, Inc., accordingly, hereby enters only a limited appearance solely for the limited purpose of furnishing certain notices regarding matters which do not appear of record before this Honorable Commission in this matter. Easy Money Auto Leasing, Inc., as former Debtor-in-Possession ("DIP") in prior pending Chapter 11 proceedings filed in the United States Bankruptcy Court For The District Of Arizona, by and through undersigned counsel for the former DIP, and at the request and upon the authority of its former President, James Cicerelli, in response to the Notice served May 15, 2001, hereby provides the above and within notices to this Honorable Commission, further giving notice that the Debtor's Bankruptcy Case was thereafter converted to a case under Chapter 7 of the Bankruptcy Code on December 6, 2000, Easy Money Auto Leasing having not conducted active business since in excess of over one year ago and, accordingly, the Honorable Commission's proposed cease and desist order appears to be moot as to it and its former officers and directors, a Chapter 7 Trustee having been appointed by the U.S. Bankruptcy Court in the Bankruptcy Case to wind up the Debtor's affairs and the Bankruptcy Case.

Accordingly, Easy Money Auto Leasing, Inc., by and through undersigned counsel as bankruptcy counsel only, for the former Debtor-in-possession, as requested and authorized by James Cicerelli, Debtor's former president, pending notification to and service upon the Trustee, would generally request a hearing and each deny the allegations of the Cease and Desist Order, and any and all liability or responsibility.

The Chapter 7 Trustee, and counsel for the Trustee, have been each appointed by the Bankruptcy Court in the Debtor's Bankruptcy Case. Because the Chapter 7 Trustee has been appointed in the Bankruptcy Case, it appears that proper service and the Commission's Notice should be directed to the Chapter 7 Trustee, whose name, address and telephone number are as follows:


