James Cicerelli, respectfully requests that the Commission continue the hearing currently set for October 1, 2001. As I have vigorously maintained that I committed no wrongdoing, at the conclusion of the July 9, 2001 pre-hearing, Ms. Kushner informally asked attorney Mark Dinell for copies of any statements or documents that would support the allegations set forth in the Notice of opportunity for hearing regarding proposed order to Cease and desist. Mr. Dinell advised that he was unwilling to provide any documents prior to any time period prescribed by the Commission. The Second Procedural Order provided that exhibits would be exchanged on September 15<sup>th</sup> 2001. On September 18, 2001 Ms. Kushner received a list of witnesses and was advised that the Exhibits were available for pick up. There are 11 individuals named on the witness list and I do not know the number of exhibits Mr. Dinell wants to introduce. Having just been apprised of the witnesses, despite a request for the information 2 months ago, I require additional time to review the documents and prepare for a hearing. Up until this point I have not had any documentation other than the Notice of

Opportunity for hearing to furnish to an attorney to evaluate my legal position and assist in my defense. This is compounded by the fact that I have been financially unable to retain an attorney, but am hopeful I will secure the requisite funds for representation.

I request a continuance of 60 days or such other time as the Commission deems appropriate. The companies which are named in this proceeding are no longer operating.
