PROCEDURAL ORDER

**BY THE COMMISSION:**

On March 5, 2003, a Procedural Order was issued in this matter which, among other things, established a procedural schedule and a June 9, 2003 hearing date. Staff's direct testimony was due to be filed by March 27, 2003.

At a Procedural Conference conducted on March 26, 2003, Staff indicated that it needed additional time to prepare its testimony because of the number of other matters with which Staff is involved. Staff was directed to attempt to gain a consensus for a revised procedural schedule before submitting its request for additional time.

On March 27, 2003, Staff filed a Request for Modification of the Procedural Schedule. Staff states that the following modified schedule has been agreed to by the other parties.

Given the apparent consensus of all parties with respect to the proposed modification of the schedule, Staff's request shall be granted, with the exception that the hearing will be scheduled to

1 begin on June 12, 2003, instead of June 11. June 11, 2003 is currently scheduled for the second day  
2 of the Commission's regular Open Meeting.

3 IT IS THEREFORE ORDERED that Staff's Request for Modification of the Procedural  
4 Schedule is granted, with the exception that the hearing shall be scheduled to commence on **June 12,**  
5 **2003, at 10:00 a.m.,** at the offices of the Commission.

6 IT IS FURTHER ORDERED that Staff's Direct Testimony shall be filed by no later than  
7 April 17, 2003.

8 IT IS FURTHER ORDERED that Intervenor Direct Testimony shall be filed by April 28,  
9 2003.

10 IT IS FURTHER ORDERED that Qwest's Responsive Testimony shall be filed by no later  
11 than May 15, 2003.

12 IT IS FURTHER ORDERED that Staff and Intervenor Reply Testimony shall be filed by no  
13 later than June 3, 2003.

14 IT IS FURTHER ORDERED that a Procedural Conference shall be scheduled in the above-  
15 captioned dockets for June 9, 2003, at 10:00 a.m., at the offices of the Commission.

16 IT IS FURTHER ORDERED that the Ex Parte Rule (A.A.C. R14-3-113-Unauthorized  
17 Communications) remains in effect for this proceeding as the matter is scheduled for public hearing.

18 IT IS FURTHER ORDERED that the Presiding Officer may rescind, alter, amend, or waive  
19 any portion of this Procedural Order either by subsequent Procedural Order or by ruling at hearing.
