
Pursuant to the March 5, 2003 Procedural Order, the hearing was originally scheduled for June 9, 2003. On March 27, 2003, Staff requested a modification to the procedural schedule, setting the date for hearing at June 11, 2003, which conflicted with the Commission's Open Meeting schedule. Subsequently, in an April 3, 2003 Procedural Order, the hearing was set for June 12. Previously, at the March 26, 2003 procedural conference, Counsel for Qwest indicated that he would be unable to appear on June 12 due to a previous commitment to speak at the State Bar of Arizona Annual Conference on that same day. At that time, however, it was possible that the conflict could be avoided and the hearing would be able to commence on June 12 regardless. Qwest has been unable to resolve the conflict, and counsel will not be available on June 12 for hearing.


