**RESPONSE TO COMMISSION
STAFF'S MOTION TO
CONSOLIDATE**

Johnson Utilities Company ("Johnson") supports the Arizona Corporation Commission Staff's motion to consolidate and request for procedural order with one clarification. Johnson filed an application requesting an extension of its existing certificate for both water and sewer service. H2O's application is just for water service, not sewer service. As a result, Johnson requests that its application for sewer service be

1 included as part of the bifurcated initial hearing on the uncontested issues. H2O has not
2 contested Johnson's request to provide sewer service even in areas in which H2O is
3 currently certificated to provide water service or in the areas in which H2O is seeking to
4 extend its water certificate. Finally, Johnson requests that these proceedings be processed
5 expeditiously and that even the hearing on the contested issues be scheduled as soon as
6 possible because property owners in the areas at issue need the service and will be harmed
7 by delay.
