
**RESPONSE OF JOHNSON

Johnson Utilities L.L.C. dba Johnson Utilities Company ("Johnson") objects to the Felix request for continuance. The Felix property is an approximately four acre parcel contained in the uncontested proceeding (Docket No: WS-02987A-00-0618). That proceeding contains a substantial amount of property and many of the other property owners desire for this proceeding to be processed expeditiously so they may proceed with development plans and receive water and sewer service. The Commission should not continue the entire hearing based on this request by an owner of property that constitutes a relatively small portion of the application. Johnson would prefer to delete the Felix property from the uncontested proceeding and its application rather than have the hearing continued.
