STAFF'S MOTION IN SUPPORT  
OF QUEEN CREEK WATER  
COMPANY'S APPLICATION TO  
INTERVENE

On October 4, 2000, Queen Creek Water Company ("Queen Creek") filed with the Arizona Corporation Commission an Application to Intervene in the above-captioned dockets. In those dockets, H2O, Inc. and Johnson Utilities, L.L.C., dba Johnson Utilities Company have filed requests to extend their Certificates of Convenience and Necessity to areas either within, contiguous to, or in the vicinity of the areas certificated to Queen Creek. Staff believes that Queen Creek should be allowed to be heard in these matters, and supports allowing Queen Creek to intervene.

However, Staff understands that granting intervention at this time raises additional procedural issues, and therefore respectfully requests that if intervention is granted, a procedural conference be scheduled for discussion of those issues.


