PROCEDURAL ORDER


BY THE COMMISSION:

On November 16, 1999, the Hearing Division issued a Procedural Order in Docket Nos. RE-00000C-94-0165, E-01787A-98-0465, E-01750A-98-0701, E-01461A-98-0466, E-01461A-97-0696, E-01749A-98-0468, and E-01703A-98-0469, setting a hearing on the stranded cost and unbundled and standard offer service tariffs of Mohave Electric Cooperative, Inc., Trico Electric Cooperative, Inc., Graham County Electric Cooperative, Inc., and Duncan Valley Electric Cooperative. The above captioned matters involving Sulphur Springs Valley Electric Cooperative Inc.'s filings for stranded cost and unbundled and standard offer service tariffs were inadvertently omitted from the November 16, 1999 Procedural Order.
