PROCEDURAL ORDER

BY THE COMMISSION:

On June 4, 2010, Mike Fricker, general manager and owner of Salt River Solar & Wind ("Salt River"), filed with the Arizona Corporation Commission ("Commission") a formal complaint against Trico Electric Cooperative, Inc. ("Trico" or Cooperative") requesting that the Commission order Trico to make solar incentive payments to Salt River in the amount of \$153,175.25 ("Complaint").

On July 1, 2010, Trico filed its Answer to Formal Complaint and Motion to Dismiss.

Pursuant to a Procedural Order filed August 3, 2010, a Procedural Conference was held on August 23, 2010, at which the parties stated that they had not settled the matter.

Accordingly, it is necessary to set oral argument on Trico's Motion to Dismiss.

IT IS THEREFORE ORDERED that **Oral Argument** on the Trico's Motion to Dismiss shall be held on **November 5, 2010, beginning at 10:30 a.m., in Hearing Room 100, 1200 West Washington, Phoenix, Arizona.**

IT IS FURTHER ORDERED that **prior to Oral Argument Salt River may file with the Commission a written reply to Trico's Answer to Formal Complaint and Motion to Dismiss.**


