Your witness John Bradshaw stated that there was no specific item that the loan funds were going to used for. Personal guarantee is not selling securities. Read John Bradshaw's testimony. You misstate what my people state. What you state against me does not apply and is not entitled to enforcement.

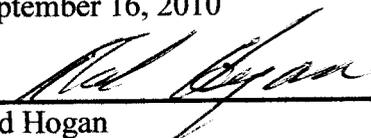

Narrative

On 01-04-05, at 1013 hours, I was dispatched to 460 Andante Dr, Sedona, in reference to a complaint of harassing phone calls and e-mails. Upon arrival I spoke with Theodore Hogan and Christina Damitio. Both parties informed me they are receiving harassing phone calls and e-mails from Elaine Roulidis over a business investment. I was informed Roulidis calls fifteen to thirty times a day and was shown a stack of printed e-mails approximately two inches thick. Damitio and Hogan informed me this has gone on since September 2004 and they have asked Roulidis not to contact them.

Damitio and Hogan did not wish to press charges at this time, they just want contact with Roulidis to stop. They stated if Roulidis contacts them after being told by police to stop, they will press charges.

I was informed Roulidis lives in Virginia. I was given a phone number and e-mail address for Roulidis. (e-mail address) I contacted Roulidis by phone on 01-04-05. Roulidis was resistant to agreeing to stop contacting Hogan and Damitio. Roulidis stated they owe her money she invested. I advised Roulidis if she felt the business deal was bad she would need to go through an attorney to contact Hogan or Damitio. After repeating this several times, Roulidis agreed to not have any manner of contact with Hogan or Damitio by way of phone, e-mail, mail or in person and to go through an attorney if she felt contact needed to be made for legal purposes.

On 03/15/05 at approximately 1317 hours I was dispatched to the Sedona Police Department in response to a report of continuing harassment.

Upon arrival I spoke with a male subject identifying himself as Theodore Hogan. Hogan made a report with Officer Dearden on 01/04/05 regarding the original incident of harassment. See included DR#2005-0047.

Hogan reported being harassed by Elaine Roulidis on a continual basis regarding a contractual disagreement. Roulidis was contacted by Officer Dearden and was advised to stop harassing Hogan. Hogan told me after Officer Dearden's phone call, Roulidis stopped contacting him for approximately 4-5 days, then resumed the harassment.

Hogan showed me approximately 27 e-mail messages from Roulidis containing threats, and harassing language. See included e-mails. Hogan has had enough, and wants to resolve the situation. While I was taking information from Hogan, Roulidis called Hogan's cellular phone 3 times within approximately 10 minutes. I could not hear what Roulidis was saying, but gathered from Hogan's responses that it was of a harassing nature.

Roulidis is accusing Hogan of taking her money illegally regarding an investment by her for \$60,000. Hogan has told Roulidis to get a lawyer, and to stop harassing him.

Hogan has been in contact with the Law Enforcement agency in West Springfield, and was told a report would not be taken until a threat of physical harm has occurred. I contacted West Springfield P.D. and was told if an injunction prohibiting harassment was issued from Arizona, they would serve it, hopefully stopping the problem. No in house contact with Roulidis was found in the West Springfield P.D. data base.

Hogan told me he is going to file a police report in Virginia, and will let me know the results. I have not been in contact with Roulidis.

This report will be forwarded to the City Prosecutors Office in consideration of filing harassment charges against Roulidis.

Nothing further at this time.

- C. **INTIMIDATION**--Respondent threatened me with physical harm or confinement, so I would obey him/her.
- D. **ENDANGERMENT**--Respondent created a risk of death or serious bodily injury to me.
- E. **KIDNAPPING/RESTRAINT**--Respondent held me against my will and interfered with my liberty.
- F. **ARSON**--Respondent burned my property or placed me in danger of death or bodily injury by fire or explosives.
- G. **INCEST**--I am a family member of Respondent and he/she had sexual contact with me.
- H. **SEXUAL ASSAULT**--Respondent had sexual contact with me without my consent.
- I. **SEXUAL INTERCOURSE WITHOUT CONSENT**--Respondent had sexual intercourse with me without my consent.
- J. **STALKING**--Respondent caused me emotional distress or fear of death or injury by repeatedly following me, harassing me, or threatening me in person, by phone, by mail or some other method.
- K. **DELIBERATE HOMICIDE or MITIGATED DELIBERATE HOMICIDE**--Respondent killed my partner or family member.

Elaine Rauldis is calling my cell telephone number 20-50 times per day. She has threatened me with bodily harm and has harassed my family for the last several months. The reports of a lot of the incidents and mail are in possession of the Under Sheriff Bob Pease. Elaine Rauldis has stated that she will call everyone to defame me until I do as she says.
She obtained a contract from me through fraudulent means. Immediately after receiving the fraudulent contract, Elaine began demands and harassment and has gone as far as harassing my wife and a lot of people at the Crow Tribe, and Herbin Park, namely American Indian employees. She has stalked me, harassed me and complete character assassination to people in the Big Horn County. Elaine Rauldis has never sent the \$66,000.00 she claims she has sent. She is now calling Thomas Fredricks, Sharon Mittereri, and others around Big Horn County.

It is pure slander, abuse of my private life this needs to stop. Elaine has been reported to the Sedona Police Department twice, that is where my second place of residence. Elaine does not seem to care what the law enforcement people tell her. My reports are with Mr. Bob Pease. I need this to stop.

All this began in June 2004 and has continued to now. And will continue.

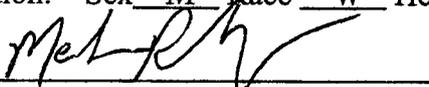

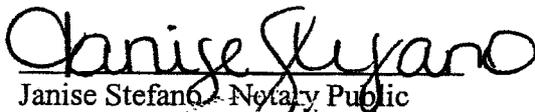

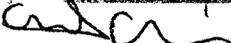

After meeting Ted Hogan, and hearing his dreams, his desires of bringing economic prosperity to his impoverished, proud people, people of the Crow Nation, by interesting a multitude of businesses to develop the unlimited natural resources present on the individually owned lands of Indians on the reservation, we loaned him the financial backing to pursue these endeavors.

At meetings with Ted we were presented with hard copy reports of viable companies he was negotiating with for oil, natural gas, wind generation, organic farming, and proposals of contracts to offer valid benefits and real money for the people he represented.

We supported his efforts with the loans given in the belief and trust that his efforts were to rectify some of the long standing injustices our government has either been guilty of committing or guilty of allowing to exist for many of the Native American Tribes.

Many people of the Crow Nation are living in abject poverty, which is a shame all to few Americans of good will are aware of or have any current knowledge of, as little or nothing of these conditions ever are reported by the media. Learning of these circumstances gave us the opportunity to contribute as our act of conscience, and to lend our support to a cause we believe in.

It is our understanding, for reasons beyond logic, certain individuals of the Office of the Inspector General of the Department of the Interior and the Bureau of Indian Affairs of Montana, have made every effort to prevent any and all businesses that would develop the natural resources belonging to individual Indians, and thereby, would bring economic independence to a whole Nation of Native Americans.

We have received reports, communications, emails to substantiate the continued efforts Ted has made to bring interested companies to the table to negotiate preliminary requirements to eventuate in contracts for the benefit of the Indians and those of us who have supported his ongoing commitment of fulfilling his promise to his people. We understand all to many of the companies who have shown expressed interests in business pursuits, who entered into negotiations, walk away because of the actions by agents of the U.S. Government and State Agencies.

We have also been made aware of the endless legal troubles all of these efforts have cost him in legal fees, prison time, and the continued prosecutions and persecutions which are ongoing and current to this date.

It is further understood by the undersigned that in the efforts these agencies have sought in legally pursuing Ted, they have violated all of his rights, both Civil and Constitutional.

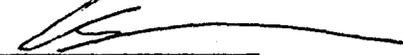
I witness Ted Hogan has my full trust and that he is proceeding diligently; exactly as he said he would in all matters with respect to my loan to him.

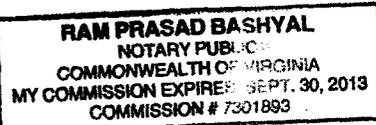
