On July 1, 2010, Tucson Electric Power Company ("TEP") filed with the Arizona Corporation Commission ("Commission") an application for approval of its 2011 Renewable Energy Standard Implementation Plan and Distributed Energy Administrative Plan and Request for Reset of Renewable Energy Adjustor.

On September 24, 2010, Freeport-McMoRan Copper & Gold, Inc. ("Freeport-McMoRan") and Arizonans for Electric Choice and Competition ("AECC") filed an Motion to Intervene.
