The Utilities Division ("Staff") of the Arizona Corporation Commission ("Commission") files its response to the filing of the Pretreatment Standards Tariff by Black Mountain Sewer Company ("Company").

The Pretreatment Standards Tariff was reviewed by Staff during the pendency of the rate case and Staff recommended approval. However, Decision No. 71865 did not approve the submission of the tariff. In light of the Company's pleading, Staff would have no objection to the issuance of an order by the Administrative Law Judge clarifying the Company's obligation to file such a tariff.
