PROCEDURAL ORDER

BY THE COMMISSION:

On February 21, 2007, Broadweave Networks of Arizona ("BNA" or "Applicant") submitted to the Arizona Corporation Commission ("Commission") an application for a Certificate of Convenience and Necessity ("Certificate" or "CC&N") to provide resold long distance, resold local exchange and facilities-based local exchange telecommunications services within the State of Arizona ("Application") and requesting that its services be classified as competitive.

On January 11, 2008, the Commission's Utilities Division ("Staff") filed its Staff Report.

On April 8, 2008, BNA filed its Request for Temporary Stay of Proceeding, and on April 14, 2008, a Procedural Order was issued granting the Request for Temporary Stay and directing the Applicant to file a Status Report by October 10, 2008.

On October 6, 2008, BNA filed its Status Report and Request for Additional Stay of Proceeding. The Applicant stated that it is not able to move forward at present and requested a stay of the proceedings for another year. Staff did not oppose the request.

On October 17, 2008, a Procedural Order was issued granting BNA's Request for Additional Stay of Proceeding and directing the Applicant to file a status report no later than October 9, 2009, but the Applicant did not file a status report as directed.

On September 29, 2010, Staff filed of a copy of correspondence sent to the Applicant asking BNA if it still wished to proceed with its Application.


1 On October 6, 2010, BNA filed a Request to Withdraw Application. Staff did not object to
2 the request.

3 Accordingly, Applicant's Request to Withdraw Application should be granted and Docket No.
4 T-20514A-07-0113 should be administratively closed.

5 IT IS THEREFORE ORDERED that Broadweave Networks of Arizona's Request to
6 Withdraw Application is granted and Docket No. T-20514A-07-0113 is hereby administratively
7 closed.


