PROCEDURAL ORDER

BY THE COMMISSION:

On May 14, 2010, Mike Fricker, general manager and owner of Salt River Solar & Wind, LLC ("Salt River") filed with the Arizona Corporation Commission ("Commission") a formal complaint against Sulphur Springs Valley Electric Cooperative, Inc. ("SSVEC" or Cooperative") requesting that the Commission order SSVEC to make solar incentive payments to Salt River in the amount of \$345,796.75 ("Complaint"), Docket No. E-01575A-10-0195.

Due to an oversight, the same Complaint was also erroneously opened under Docket No. E-01575A-10-0196.

Accordingly, because Docket No. E-01575A-10-0196 was opened in the error, it should be administratively closed.


