PROCEDURAL ORDER

BY THE COMMISSION:

On March 1, 2010, Gary R. Bahr and Larry C. Rowley ("Complainants") filed with the Arizona Corporation Commission ("Commission") a Complaint ("Complaint") against Time Warner Cable Information Services (Arizona), LLC, d/b/a Time Warner Cable ("Respondent").

On March 24, 2010, the Respondent filed its Motion to Dismiss the Complaint.

On June 9, 2010, a Procedural Order was filed setting oral argument in the Respondent's Motion to Dismiss for July 1, 2010.

The matter convened at the date and time set. The Respondent appeared through counsel, but the Complainants did not appear. Pursuant to a Procedural Order filed August 4, 2010, a procedural conference was set in order to determine a date and time for oral argument on the Respondent's Motion to Dismiss. The Procedural Order stated that if the Complainants failed to appear at the Procedural Conference without just cause, the Complaint would be dismissed.

On September 17, 2010, the Procedural Conference convened as scheduled. The Respondent appeared through counsel, but the Complainants again failed to appear.


The Complainants have failed to appear for a Procedural Conference and for oral argument.

1 The Complainants were advised in the August 4, 2010, Procedural Order that if they failed to appear
2 at the September 17, 2010, Procedural Conference, the Complaint would be dismissed.

3 Accordingly, because of the Complainants' failure to participate, the Complaint should be
4 dismissed.

5 IT IS THEREFORE ORDERED that Docket No. T-20449A-10-0081, In the Matter of the
6 Formal Complaint of Gary R. Bahr and Larry C. Rowley, Complainants, and Time Warner
7 Cable Information Services (Arizona), LLC, DBA Time Warner Cable, Respondent, is hereby
8 dismissed without prejudice.


