Notice of Errata to the Joint Application of Integra Telecom Holdings, Inc., Eschelon Telecom of Arizona, Inc. dba Integra Telecom, and National Brands, Inc. d/b/a Sharenet Communications Company for Waiver of the Commission's Slamming Rules, AAC R14-2-1904

To Whom It May Concern:

On October 19, 2010, Integra Telecom Holdings, Inc. together with its Arizona operating subsidiary Eschelon Telecom of Arizona, Inc. dba Integra Telecom (together "Integra"), and National Brands, Inc. d/b/a Sharenet Communications Company ("Sharenet") (together, "the Parties") filed an application with the Arizona Corporation Commission ("Commission") for a waiver of the Commission's Slamming Rules, specifically AAC R14-2-1904.A. Included with the Parties' Joint Application ("Application") was a copy of the Asset Purchase Agreement ("Agreement"), marked as Exhibit A and designated "Confidential - Not for Public Disclosure." Commission Staff immediately contacted Integra, the filing party, and informed the Company that confidential material cannot be submitted to Docket Control unless prior arrangements are made with the Commission's Hearing and/or Legal Division(s). Commission Staff stated that the confidential material would be returned to Integra, but that the Application has been docketed and would move forward.

The Parties respectfully request that Commission Staff assigned to the review and analysis of the Application disregard the reference to Exhibit A, found on Page 3, Section VI, Line 4, of the Application. The Parties will work directly with Commission Staff to determine the appropriate handling of the Agreement should they find the need to review this material.
