17 **BY THE COMMISSION:**

18 On May 17, 1999, Arizona Public Service Company filed with the Arizona Corporation  
19 Commission a Notice of Filing, Application for Approval of Settlement Agreement ("Settlement  
20 Agreement") and Request for Procedural Order.

21 Our May 25, 1999 Procedural Order set the above-captioned matter for hearing commencing  
22 on July 14, 1999 and setting dates for the filing of testimony and granting of intervention.

23 The following are either signatures to the Settlement Agreement or have requested and been  
24 granted intervention in the Settlement Agreement docket and therefore should receive copies of all  
25 testimony filed<sup>1</sup>:


1 Choice and Competition (collectively "ASARCO"), Enron Corp. ("Enron"),

3 Power Company ("TEP"), NEV Southwest, L.L.C. ("NEV Southwest"),  
4 Navopache Electric Cooperative, Inc. ("Navopache"), Sempra Energy Trading


