PROCEDURAL ORDER
GRANTING ADMISSION
PRO HAC VICE

BY THE COMMISSION:

On October 29, 2010, pursuant to Arizona Supreme Court Rule 38(a), Martin R. Galbut and Michaile J. Berg of Galbut & Galbut, P.C., filed with the Arizona Corporation Commission ("Commission") a Motion to Associate Counsel *Pro Hac Vice* for Kevin M. Downey in the above-captioned matter, on behalf of Interested Parties Greenberg Traurig, LLP and Robert S. Kant. The Motion lists Martin R. Galbut and Michaile J. Berg as the designated members of the Arizona State Bar with whom communications may be made and upon whom papers should be served. 
