7 Therein, the Commission ordered the Respondents to appear before the Commission, at a time
 8 and place designated by the Hearing Division, and show cause why the Commission should not
 9 assess penalties against the Respondents as provided in A.R.S. §§ 40-424 and 40-425 and/or cancel
 10 the Respondents' Certificates of Convenience and Necessity.

11 Accordingly, it is appropriate to establish the procedural schedule for this matter.

12 IT IS THEREFORE ORDERED that a **Procedural Conference shall be held on December**
 13 **13, 2010, at 10:00 a.m.**, or as soon thereafter as is practicable, at the Commission's offices, 1200
 14 West Washington Street, Hearing Room #1, Phoenix, Arizona.

15 IT IS FURTHER ORDERED that the Commission's Utilities Division ("Staff") shall file by
 16 **December 6, 2010**, a memorandum in this Docket indicating which, if any, of the above-named
 17 Respondents have filed 2008 Annual Reports since the issuance of Decision No. 71959.

18 IT IS FURTHER ORDERED that the **hearing on the OSC shall be held on January 6, 2011,**
 19 **at 10:00 a.m.**, or as soon thereafter as is practicable, at the Commission's offices, 1200 West
 20 Washington Street, Hearing Room #1, Phoenix, Arizona.

21 IT IS FURTHER ORDERED that all parties must comply with Rules 31 and 38 of the Rules
 22 of the Arizona Supreme Court and A.R.S. § 40-243 with respect to practice of law and admission *pro*
 23 *hac vice*.
