PROCEDURAL ORDER

**BY THE COMMISSION:**

On April 29, 2010, Arizona Public Service Company ("APS" or "Company") filed with the Arizona Corporation Commission ("Commission") an application in Docket No. E-01345A-10-0166, pursuant to the requirements of Decision No. 71448 (December 30, 2009), for approval of a new program for on-site solar energy for schools and governmental institutions ("Schools and Government Program").

On July 1, 2010, APS filed an application in Docket No. E-01345A-10-0262 for approval of the Company's 2011 Renewable Energy Standard Implementation Plan ("2011 Plan") and Distributed Energy Administration Plan and Request for Reset of Renewable Energy Adjustor.

On July 26, 2010, by Procedural Order, the dockets were consolidated.

On October 28, 2010, The Solar Alliance ("Solar Alliance") filed a Motion to Intervene.

No objections to Solar Alliance's Motion have been filed, and accordingly the Motion should be granted.

IT IS THEREFORE ORDERED that Solar Alliance is hereby granted intervention.

1 IT IS FURTHER ORDERED that the Administrative Law Judge may rescind, alter, amend,  
2 or waive any portion of this Procedural Order either by subsequent Procedural Order or by ruling at  
3 hearing.


