Page 12, Line 9.5 INSERT New Finding of Fact: "The Commission believes that Arizona utilities must develop enhanced outreach efforts to inform customers of the available incentives for demand side management programs and measures. Specifically, we believe it is in the public interest for UNS Gas to participate in creating a joint website, modeled after "Arizonagoessolar.org", with other ACC-regulated utilities that would make available to Arizonans at a minimum, information regarding the availability of all residential and commercial energy efficiency incentives, including utility rebates offered through the GES, as well as applicable state and federal tax credits; information about the GES; information regarding any relevant Commission sponsored workshops on energy efficiency; and information regarding the status of the utility's efforts toward meeting the GES.

Moreover, we believe this web site should make available twice monthly on the new web site at least the following information: incentive programs available; the amount of incentive offered; and funds spent to date and funds available."

Page 14, Line 3.5 INSERT New Ordering Paragraphs: "IT IS FURTHER ORDERED THAT UNS Gas shall participate in the creation of a new web site, modeled after "Arizonagoessolar.org", and UNS Gas shall seek the participation of all ACC-regulated utilities for the purpose of joint operation of the web-site. The web-site will provide Arizonans at a minimum information regarding the availability of energy efficiency incentives, including utility rebates offered through the GES, and state and federal tax credits; information about the GES; and information regarding the status of the Company in meeting the GES.

IT IS FURTHER ORDERED that UNS Gas shall make publicly available, twice monthly, via the new web site at least the following information: incentive programs available; the amount of incentive offered; funds spent to date and funds available.

IT IS FURTHER ORDERED that Utilities Division Staff shall annually file each November 1<sup>st</sup> beginning in 2011, a memorandum stating whether the website is in compliance with this Decision, and if the website is not in compliance, Staff shall list the reasons why."
