

The Securities Division ("Division") of the Arizona Corporation Commission ("Commission") opposes Jere Parkhurst's ("Parkhurst") last minute request for a continuance of the December 2, 2010, pre-hearing conference "until a later date in January due to the [h]oliday." The pre-hearing conference date was scheduled on October 20, 2010. If there was a conflict with a holiday, Parkhurst could have informed both Administrative Law Judge Stern ("ALJ Stern") and the Division before November 29, 2010.

Parkhurst also stated that he was "still in the process of retaining [l]egal [c]ounsel." Prior to Parkhurst's November 29, 2010, filing, Parkhurst stated in his October 18, 2010, request for a hearing that he was seeking to retain legal counsel. Parkhurst has now had close to seven weeks to retain counsel. Any counsel eventually retained by Parkhurst can appear after this initial pre-hearing conference.
