Greetings Commissioners:

I was told today that Telesphere Access, LLC, apparently a subsidiary of Telesphere Networks LTD of Washington state is asking the state of Arizona to grant them a CERTIFICATE OF CONVENIENCE AND NECESSITY to operate as a telephone company within the state of Arizona.

I understand that there is to be a hearing on Friday December 3 at 10:00AM which I highly desire to attend, however I will be in California at that time.

On 9/21/2010 I filed suit against 11 companies of "Locksmith Scammers", several telephone companies, and others. The "locksmith scammers", as part of their business model, in civil and criminal violation of A.R.S. §44-122 1, purchase or subscribe to telephone numbers ranging in quantities from dozens to hundreds. Once the "scammers" have procured the numbers from the telephone company they then the telephone company issuing said telephone numbers with phony addresses that these "locksmith scammers" have literally no connection to, usually addresses belonging to other businesses, residences, vacant lots or simply entirely non-existent. In conjunction with the addresses the "scammers" provide "business names" some of which are actually registered with the State of Arizona but often as not they will make up bogus names as well. After the "scammers" have assembled their collection of phony addresses and real or bogus company names to go with them, they will return this contrived "collection" of data to the telephone company for insertion into that telephone company's internal "directory information database" which at some subsequent time enters public domain.

The entire business model described above is meant to accomplish at least two goals. The first being to saturate all printed directories, 411 directory assistance listings, and ultimately internet search engines such as Google and Yahoo! with such a vast number of listings that consumers ultimately (and frequently repeatedly during a single shopping expedition) contact the scammer companies nearly exclusively. The second goal is to confuse consumers into believing they are speaking with a company that is in close proximity to them (when they may be talking to a call center in another state) completely violating the specific language and the spirit of the A.R.S. §44-1221 statute which states:

44-1221. Deceptive use of name classification attorney enera1

A. It is unlawful for a person to deceive another person by misrepresenting the geographical origin or location of the person's business in the conduct of the person's business.

B. A person who intentionally or knowingly violates subsection A of this section is guilty of a class 2 misdemeanor.

C. An act or practice in violation of this section is an unlawful practice under section 44-1522 and subject to enforcement through private action and prosecution by the attorney general. The attorney general may investigate and take appropriate action as prescribed by chapter 10, article 7 of this title.

Pursuant to a stipulated judgment, 360 Networks, which I was informed is only a wholesaler of telephone services to other companies, was dismissed from the case and voluntarily complied with my Subpoena Duces Tecum for records relating to many of these locksmith companies. Of the approximately 450 telephone numbers listed on the Subpoena Duces Tecum 360 networks provides the wholesale service for 123 of these numbers. Of those, the information I was provided by 360 Networks indicates that 96 of those phone numbers are resold to consumers by Telesphere Networks, LTD, 23 of those numbers are resold to consumers by Freeway Communications, and 4 are resold to consumers by Velocity Networks, Inc.

This afternoon I spoke with Mr. Lee Reeves of Freeway Communications to open a dialog and I may meet with him during my trip to California to show him the evidence I have collected over the past two years.

This afternoon I also spoke with Mr. Mike Target, legal counsel for Telesphere who was considerably less than cooperative in even contemplating opening a dialog so he could gain more understanding of the issue of all of the phony addresses being associated with the 96 telephone numbers that his company is supplying to the "Locksmith Scammers" almost, if not exclusively to ATLAS LOCKSMITH SOLUTIONS LLC and their new alter-go company MILLER LOCK & SAFE, LLC.

In my ongoing civil action in Maricopa County Superior Court, Charles Eastwood vs. ATLAS LOCKSMITH SOLUTIONS LLC, et. al. Case No.: CV2010 027605, I have, or am about to dismiss almost all of the telephone company entities so far named in my complaint because they have demonstrated to my satisfaction that they have in place "internal policies" that they choose not to make public which prohibit the above described very activities with which Telesphere is apparently quite comfortable in facilitating for the "locksmith scammers" and Lord only knows who else in what other business categories.

I knew at the onset of this action that I would be finding "good guys" and "bad guys" in the telecommunications industry because (a) the "good guys" have been doing it right for years to decades, and as I was informed today QWEST (formerly US WEST) has been doing so prior to Arizona's statehood; and (b) if the "bad guys" were simply out to make a few extra dollars their activities would be exposed.

Well Commissioners, I am here to testify to the devastation that the activities of the "bad guys" have caused to the good and decent genuine "legitimate" locksmiths that have served their country and their consumers for years with few if any complaints.

I have a good locksmith friend Jeff. Jeff has lost his house and has moved his wife and children in with the in-laws on what appears to be, by necessity, a permanent basis. I have another good locksmith friend, Warren who has not only lost his house and moved his family in with his parents, but he has lost two shops too. Personally on 4/20 I filed bankruptcy and I don't know how its managed to take this long, but my assistant tells

me that the foreclosure date for my home is 12/15/20 10 (was originally 4/23 before I filed the bankruptcy.)

If it comes to pass that Telesphere and their attorney Mr. Target maintain the position that they wish to continue to conduct "business as usual" (i.e. supplying the "Locksmith Scammers" with multitudes of telephone numbers together with the ability to cause directory listings to be entered into the directory database(s) maintained either by their company or the companies whose services they are re-selling) I will have no option but to name them as defendants in my first amended complaint sometime after I acquire a bit more discovery likely after the first of the year. I would of course be alleging that they are engaging in a conspiracy that is both criminal (misdemeanor under §44-1221, or feloniously under ARS §13-23 10 "A. Any person who, pursuant to a scheme or artifice to defraud, knowingly obtains any benefit by means of false or fraudulent pretenses, representations, promises or material omissions is guilty of a class 2 felony.") as well as civilly as an unlawful practice under section 44-1522. Clearly, any officer, employee, or attorney working for a company such as Telesphere that may ultimately be criminally charged under such statutes, or be the defendants in civil suits seeking to injunctive relief to prohibit these unfair business practices do not in any way deserve the consideration of the Arizona Corporation Commission to be conferred with a "CERTIFICATE OF CONVENIENCE AND NECESSITY" to operate any public utility within the state of Arizona because the citizens of the great State of Arizona do not deserve to be victimized by such conspiracies to commit consumer fraud against the citizens of Arizona.

Equally as clearly, any attorney, such as Mr. Target, who refuses to negotiate in good faith and ultimately fails to "do the right thing" and fails to advise his company to discontinue service to people / companies that are obviously engaging in criminal behavior may not only find themselves being sued personally, but may ultimately find themselves to be the target of one or more bar association complaints alleging their complicity in a conspiracy involving ongoing criminal activities and may ultimately find themselves disbarred.

I am attaching a multi-page document the first 3 pages being from 360 networks in response to my Subpoena, the pages following demonstrating the phony names and addresses that ATLAS is or was using over my two year investigation into this matter.

I am also attaching a copy of my letter to Chairman Mayes of November 13 relative to the necessity of making a global rule for all telecommunications carriers to verify addresses of consumers or companies wishing to have published in the "directory database(s)" addresses where they have no physical services installed. While I recognize that I am taking a very strong position here, I want there to be no misunderstanding. Qwest and others have complained that I "desire" to interfere with or eliminate their "MEL" (market expansion line) [formerly known as 'remote call forwarding'] service. This is absolutely NOT the case.

If a company wishes to HONESTLY advertise "Our main office is located at . . (say downtown Phoenix). and we also serve Tempe, Mesa, Gilbert and you can call our 480 number.... And we service Avondale, Goodyear, Tolleson and you can call our 623 number..." I have no problem with honesty and integrity. The problem that I am describing is when companies DISHONESTLY imply by placing a 4400 N. Central Ave address when the call is being answered by their Colorado or Florida call center THAT is what is prohibited by statute.

Unfortunately I'm going to be out of town for the 12/3 hearing on this matter, but if the commission would like to call me as a witness upon my return I'll be more than happy to testify. Furthermore, I would like to direct the commissioners to my website <http://www.TheLocksmithPolice.com/exhibits> where all of the stuff I'm filing in court may be viewed by the commission and the public.

I wish to give my thanks to Mr. Brad Morton who invited me to send him all of my information by e-mail so I wouldn't have to produce "an original and 13 copies"
