BY THE COMMISSION:

On September 17, 2010, Goodman Water Company ("Goodman" or "Company") filed an application with the Arizona Corporation Commission ("Commission") for a rate increase.

By Procedural Order dated November 16, 2010, the matter was set for hearing and procedural guidelines were established.

On November 24, 2010, Mr. Lawrence Wawrzyniak and Mr. James Schoemperlen, residents of the Eagle Crest Ranch Housing Development and customers of Goodman, filed an Application to Intervene. Mr. Wawrzyniak and Schoemperlen request intervention as individuals, but they state that the are also members of an ad hoc group of residents who oppose to an increase in water rates.


