**CLARIFICATION TO RECOMMENDED
OPINION AND ORDER**

The Utilities Division ("Staff") of the Arizona Corporation Commission files the following clarification to the recommended opinion and order ("ROO"). Staff's clarification provides further details and guidance to Rio Rico Utilities, Inc. regarding the filing of Best Management Practices as tariffs conforming to the templates created by Staff. Staff suggests that on Page 57, line 19, the thirty days be replaced with ninety days. Staff also suggests that the ordering paragraph on Page 59, Lines 1-3 be deleted and in its place, Staff suggests the following additional Ordering Paragraph:

"IT IS FURTHER ORDERED that within 90 days of the effective date of this decision, Rio Rico Utilities, Inc. submit its ten Best Management Practices, as a compliance item is this docket, in the form of tariffs that substantially conform to the templates created by Staff (and available on the Commission's Website) for the Commission's review and consideration."

Staff would also note a typographical error on page 41, line 19; it should read "3.83" instead of ".83".
