BY THE COMMISSION:

On May 5, 2006, in Decision No. 68691, the Arizona Corporation Commission (“Commission”) granted Navopache Electric Cooperative, Inc., an Arizona non-profit corporation (“Navopache”), authority to borrow funds from the Rural Utilities Service Guaranteed Federal Financing Bank to finance plant construction according to Navopache’s construction work plan for 2005-2008 (“Work Plan”).

On January 28, 2010, Navopache filed a Notice of Amended Work Plan (the “Notice”) related to Docket No. E-01787A-05-0719. Because the document submitted did not contain a complete docket number, a new docket was created, Docket No. E-01787A-10-0030. Navopache requested that this docket be closed and by procedural order dated April 19, 2010, this docket was administratively.

On May 26, 2010, Navopache filed a letter to the Commissioners Re: Expedited Request by Navopache Electric Cooperative, Inc. to Amend Decision No. 68691 pursuant to Arizona

3 granted the motion by Navopache on June 10, 2010.

4 On September 1, 2010, the Commission issued Decision No. 71859 which approved
5 Navopache’s motion to amend.

6 On September 8, 2010, Navopache filed a Motion to Correct Clerical Mistake, Or
7 Alternatively, Motion To Amend Decision No. 71859. Therein, Navopache identified a clerical
8 mistake which it requests be corrected.

9 ORDER

10 IT IS THEREFORE ORDERED that Decision No. 71859 shall be amended to correct the
11 following clerical error: the duplicative ordering paragraph found at Page 5, lines 15-17 is deleted.

3 IT IS FURTHER ORDERED that this Order shall become effective immediately.




