PROCEDURAL ORDER

BY THE COMMISSION:

At a Special Open Meeting held on April 14, 1999, the Arizona Corporation Commission ("Commission") ordered the Utilities Division Staff ("Staff") to forward proposed Rules R14-2-201 through -207, -210 and -212, and R14-2-1601 through -1618 ("Proposed Rules") to the Office of the Secretary of State for Notice of Proposed Rulemaking as soon as possible. In the Decision issued pursuant to the April 14, 1999 Special Open Meeting, (Decision No. 61634), the Commission also ordered the Hearing Division to issue a Procedural Order scheduling oral proceedings on this matter. Pursuant to Decision No. 61634, a Procedural Order was issued on April 21, 1999 establishing public comment hearing dates and a schedule for the submission of both initial written comments and responsive written comments prior to the public comment hearings.

In order to insure maximum public input, additional public comment hearings during the evening hours are hereby scheduled as follows:

IT IS THEREFORE ORDERED that additional public comment hearings on the above-captioned matter shall be held on June 21, 1999 commencing at 6:00 p.m., at the Commission's offices, Room 222, 400 West Congress Street, Tucson, Arizona 85701, and on June 23, 1999 commencing at 6:00 p.m., at the Commission's offices, 1200 West Washington Street, Phoenix, Arizona.

IT IS FURTHER ORDERED that the previously scheduled public comment hearings on the above-captioned matter, as published in the Arizona Administrative Register on May 14, 1999, shall be held as scheduled on June 14, 1999 at 10:00 a.m. or as soon thereafter as is practical, at the Commission's offices, 1200 West Washington Street, Phoenix, Arizona, and on June 17, 1999 at

1 10:00 a.m. or as soon thereafter as is practical, at the Commission's offices, Room 222, 400 West
2 Congress Street, Tucson, Arizona 85701.


3 IT IS FURTHER ORDERED that although comments in this matter will be taken through
