PROCEDURAL ORDER

BY THE COMMISSION:

On September 29, 1999, in Decision No. 61969, the Arizona Corporation Commission ("Commission") adopted final Electric Competition Rules ("Rules"). On December 17, 1999, Sierra Southwest Electric Power Services Cooperative, Inc.; and Arizona Electric Power Cooperative, Inc. and its five member distribution cooperatives (Duncan Valley Electric Cooperative, Inc.; Graham County Electric Cooperative, Inc.; Mohave Electric Cooperative, Inc.; Sulphur Springs Valley Electric Cooperative, Inc.; and Trico Electric Cooperative, Inc.) (collectively "the Cooperatives"), filed a Request for an Extension of Time to File their Code of Conduct ("Request").

The Cooperatives indicated that the Commission has not yet entered orders concerning the Cooperatives' Stranded Cost. As a result, the Cooperatives' service territories are not open to competition and the requested extension will not impact any interest. Accordingly, the Cooperative requested an extension to file their Code of Conduct(s) until February 4, 2000.¹ The Cooperatives also indicated that the Staff of the Commission did not oppose the Request.

Based on the above, we find good cause to grant the Request.

¹ Pursuant to Rule A.A.C. R14-2-1616, the Code of Conduct(s) was to be submitted on or before December 29, 1999.


1 IT IS THEREFORE ORDERED that the Request is hereby granted and the Cooperatives shall
