PROCEDURAL ORDER

**BY THE COMMISSION:**

At the January 21, 2000 Status Conference Navaopache Electric Cooperative, Inc. ("Navopache") reported that it had circulated among interested parties a draft settlement agreement addressing the issue of Navopache's stranded costs. The parties present at the status conference expressed a desire for additional discussions in an attempt to resolve the remaining issues in this matter.


