PROCEDURAL ORDER

BY THE COMMISSION:

On April 30, 2010, Indiada Water Company (“Indiada”) filed with the Arizona Corporation Commission (“Commission”) an application for a permanent rate increase, under Docket No. W-02031A-10-0168.

On April 30, 2010, Antelope Run Water Company (“Antelope”) filed with the Commission an application for a permanent rate increase, under Docket No. W-2327A-10-0169.

On April 30, 2010, East Slope Water Company (“East Slope”) filed with the Commission its application for a permanent rate increase, under Docket No. W-01906A-10-0170.

On April 30, 2010, Indiada, Antelope Run and East Slope filed with the Commission a joint application for the transfer of Indiada’s and Antelope Run’s Certificates of Convenience and Necessity (“CC&N”) to East Slope and for consolidation of rates under Docket Nos. W-02031A-10-0171, W-02327A-10-0171, and W-01906A-10-0171.

On May 7, 2010, East Slope filed with the Commission an application for authority to incur long-term debt, under Docket No. W-01906A-10-0183.

On May 7, 2010, Indiada filed with the Commission an application for authority to incur long-term debt, under Docket No. W-02031A-10-0184.

On May 7, 2010, Antelope Run filed with the Commission an application for authority to incur long-term debt, under Docket No. W-02327A-10-0185.

On December 29, 2010, East Slope, Indiada and Antelope Run filed Motions Regarding Sufficiency of Rate Application in each company’s rate application dockets, as well as in the joint

1 application for transfer of CC&Ns and rate consolidation docket.

2 Accordingly, a procedural conference is necessary to discuss the Motions and also to discuss
3 the possibility of consolidation of the dockets.

4 IT IS THEREFORE ORDERED that a **Procedural Conference** shall be held on **February 8,**
5 **2011, at 10:00 a.m.**, at the Commission's Tucson office, **Room 222**, 400 West Congress, Tucson,




