MOTION FOR RECONSIDERATION

15 Truxton Canyon Water Company (“Company”), by and through its attorney
16 undersigned, respectfully submits this Motion for Reconsideration regarding the
17 Procedural Order issued in this matter on January 5, 2011 (“Order”).

19 Company does not ask for reconsideration of the entire Order, but rather that
20 portion of the Order requiring Company to “**mail, via First Class Mail, to each of its**
21 **customers, on or before January 13, 2011, notice of the hearing in this matter by**
22 **enclosing a copy of the Procedural Order issued September 2, 2010, as well as a**
23 **copy of Commission Decision No. 71837 (August 10, 2010).”** While Company will
24 post such documentation on its website, it is not able to comply with the request given the
25

1 short deadline and the cost of sending such documentation to 887 customers. The cost of
2 notice required by the Order is calculated to be approximately \$2,200.00 and these funds
3 should be used to improve its water systems for its customers.

5 Posting the documents referenced in the Order on the Company's website is
6 sufficient notice and is the most timely and cost-effective way to comply with the Order.
7 The Company has already been required to expend substantial legal fees to navigate
8 through Staff's barrage of claims. The Company recognizes the importance to its
9 customers to receive quality water at fair and reasonable prices and it continues to strive
10 to offer water to its customers at a fair price.

12 The Company respectfully requests that this body grant this Motion for
13 Reconsideration amending the Order to state that the Company may post such
14 documentation referenced therein to its website.
