I am in support of the project at this location but have misgivings about the lack of effort to make this project blend in with the surrounding residential property. I am now of the understanding that it is proposed that the project be surround by a chain-link fence eight feet tall and topped with barbed wire. This will have the appearance similar to that of a prison.

This is totally unacceptable to me and here is why:
