
On October 3, 2008, The Solar Alliance filed an application for a declaratory order that providers of certain solar service agreements would not be public service corporations pursuant to Article 15, Section 2 of the Arizona Constitution. On October 5, 2010, the Applicant filed its Notice of Intention, which states they no longer intended to pursue the application in this matter. On November 19, 2010, Staff filed a response to the Company's Notice of Intention, which suggested this docket be administratively closed without prejudice to Applicant's ability to refile in the future.

Per Procedural Order issued on December 1, 2010, by Teena Jibilian Administrative Law Judge, there are no objections to this request. Therefore, this docket is administratively closed.


