PROCEDURAL ORDER

**BY THE COMMISSION:**

In a Procedural Order dated August 23, 2010, a procedural schedule for filing pre-hearing briefs was established and the parties were afforded the opportunity to request oral argument.

On December 8, 2010 Pac-West Telecomm, Inc. ("Pac-West") requested oral argument.

On December 9, 2010, Level 3 Communications, LLC ("Level 3") joined in Pac-West's request.

On December 22, 2010, Qwest Corporation ("Qwest") filed a Response to the Request for Oral Argument. Qwest did not object to oral argument but suggested it should be scheduled after the Washington Utilities and Transportation Commission rules on the same issues.


Briefing is concluded and Pac-West's request is timely. While the Washington Commission's

7 any portion of this Procedural Order either by subsequent Procedural Order or by ruling at hearing.
