To Whom It May Concern:

In connection with the extension of the Certificate of Environmental Compatibility ("CEC") issued to Ajo Improvement Company ("AIC") (Docket No. L-00000G-97-0089) in Decision No. 70957 on April 7, 2009 ("Decision"), AIC is submitting this letter pursuant to the provisions of A.R.S. 40-360.02(A) to update the Arizona Corporation Commission ("Commission") concerning the construction of its transmission line ("Project").

At the outset, it should again be stated that AIC has not yet commenced construction of the Project due to the continuation of the economic factors related to the electric load that would be served by the project. AIC continues to monitor market conditions and economic forecasts in order to determine when such conditions will warrant the construction of the project.

There has been no change in the Ajo Improvement Company Ten-Year Plan Power Flow and Stability Analysis ("Plan") which was filed with the Commission on January 7, 2009. AIC will update the Commission on an annual basis of any changes in the Plan.
