FINDINGS OF FACT

1. On August 31, 2010, Cox Arizona Telcom, L.L.C. ("Cox") filed tariff revisions to increase a rates in its Arizona CC Tariff No. 1. The filing seeks to increase Cox's local access line business flat rate service maximum and monthly recurring rates from \$30 to \$32:

2. On September 21, 2010, Cox requested a delay in Staff's review of Cox's application to allow customer notices to be properly scheduled.

3. Since this filing increases the maximum rate for a component of a service that has been classified as competitive under the Commission's Competitive Telecommunications Service Rules, Arizona Administrative Code Rule ("A.A.C.") R14-2-1110 applies to Cox's proposal. Cox provided the information required by A.A.C. R14-2-1110 to allow Staff to determine the potential effects of approval of the filing.

1 2. The Commission has jurisdiction over Cox Arizona Telcom, L.L.C. and over the
2 subject matter of this Application.


3 3. The Commission, having reviewed the tariff pages (copies of which are contained in

5 tariff filing is reasonable, fair and equitable, and is therefore in the public interest.

6 ORDER


7 IT IS THEREFORE ORDERED that this tariff filing by Cox Arizona Telcom, L.L.C. be

9 IT IS FURTHER ORDERED that this Decision shall become effective immediately.




