**STAFF'S REQUEST FOR AN EXTENSION
OF TIME**

Cerbat Water Company ("Company") filed an application requesting an increase in rates on June 1, 2010. The Utilities Division Staff ("Staff") filed a sufficiency letter on November 17, 2010, deeming the Company's application as a Class D water utility sufficient. The sufficiency letter stated that Staff would docket a Staff Report on or around January 29, 2011. Per Arizona Administrative Code R14-2-103(B)(11)(b)(iv), a Staff Report for a Class D utility shall be filed within 75 (seventy-five) days of finding the application sufficient. Due to unanticipated matters brought before the Commission, Staff schedules and the depth of analysis needed in this application in light of developments in related matters in other dockets, Staff respectfully requests an extension of time, until February 4, 2011 to file this report.
