

**PUBLIC NOTICE OF HEARING**  
**ON REHEARING AND RECONSIDERATION OF DECISION NO. 72026**  
**Docket No. SW-01428A-09-0103 et al.**

On March 9, 2009, Litchfield Park Service Company (“LPSCO” or “Company”) filed with the Arizona Corporation Commission (“Commission”) an application for a determination of the current fair value of its utility plant and property and for increases in its rates and charges for water and wastewater utility service provided to customers in the Company’s certificated service area in Maricopa County, Arizona. On December 10, 2010, the Commission issued Decision No. 72026 granting a rate increase to LPSCO. On December 29, 2010, LPSCO filed an Application for Rehearing on the Commission’s decision to adopt a return on equity (ROE) of 8.01%, along with the Commission’s decision to phase-in the rate increases and other related issues. On January 14, 2011, the Residential Utility Consumer Office filed a Request for Reconsideration Under A.R.S. § 40-252 seeking reconsideration of certain rate base issues. During a Staff Meeting held on January 18, 2011, the Commission granted LPSCO’s application for rehearing and RUCO’s request for reconsideration.
