**BY THE COMMISSION:**

By Procedural Order dated November 3, 2010, this matter was set for arbitration and procedural deadlines were established.

On January 26, 2011, North County Communications Corporation ("North County") filed a Motion to Extend Time for Reply Testimony and Arbitration Hearing. North County requested the extension because it engaged new counsel for the arbitration proceeding. North County states that Qwest Corporation's ("Qwest") counsel had no objection. IT IS FURTHER ORDERED that **the deadline for filing Rebuttal Testimony is extended until February 11, 2011.**
