FINDINGS OF FACT

A. Introduction

1. At the Open Meeting of February 1-2, 2011, the Arizona Corporation Commission (“Commission”) authorized Sahuarita Water Company, LLC (“Sahuarita” or “Company”) to implement, after Commission approval, a Central Arizona Groundwater Replenishment District (“CAGR”) adjustor fee for its Tucson Active Management Area (“AMA”), subject to the conditions recommended by Staff.
