**STAFF'S REPLY TO MOTION FOR EXTENSION OF TIME**

The Utilities Division of the Arizona Corporation Commission ("Staff") hereby replies to Arizona Water Company's ("AWC") Response to Staff's Motion for Extension of Time. Staff understands that AWC "does not object to an appropriate extension of time" and "is willing to agree that Staff may have until Friday, February 18, to file its response . . . ." While Staff appreciates the Company's concession in this regard, it will not provide Staff with adequate time to fully respond to the issues addressed in the Company's Motion so that the Administrative Law Judge's ("ALJ") has fully developed arguments from Staff and the Company for her consideration. As Staff indicated in its motion, the lead attorney in this matter is out of the office on Friday, February 11, in the afternoon until Tuesday, February 15. Staff therefore reiterates the need for an extension of time until Wednesday, February 23, 2011.
