

American Fiber Network, Inc. ("Applicant") has filed with the Arizona Corporation Commission ("Commission") an application for authorization to discontinue competitive telecommunications services in the State of Arizona on February 20, 2011 and to relinquish its Certificate of Convenience and Necessity on February 21, 2011.

A.A.C. R14-2-1107 provides that the Commission may act on an application to discontinue telecommunications services without a hearing, or with a hearing, if one is requested by any party. Applicant or any other party must request a hearing within thirty (30) days of the date of this notice, or the Commission will rule on the application without a hearing.



You may have the right to intervene in the proceedings, or you may make a statement for the record.
